# **About the Theme**

#### "Comparative Criminal Law in the Contemporary World"

The committee encourages critical and interdisciplinary engagement with themes of criminal law, criminal justice reform, and comparative criminal jurisprudence. The upcoming volume is focused on understanding and analyzing how legal systems across the world adapt to evolving challenges in the criminal justice domain. The aim is to generate ideas, facilitate legal discourse, and provide a platform for emerging voices in the field.

With Volume 1, Issue 1, the ACLSC Journal aims to foster critical scholarship and meaningful dialogue on how legal traditions in criminal law can learn from critique, and complement one another. # **Submission Categories**

We welcome original, unpublished manuscripts in the following categories:

- 1. Long Articles (3,000–6,000 words, excluding footnotes)
- 2. Short Articles/Essays (1,500–3,000 words, excluding footnotes)
- 3. Case Notes and Legislative Comments (1,200–2,500 words)





# SUBMISSION GUIDELINES

#### Who can submit?

Submissions are invited from both students and faculty members of the School of Law, CHRIST (Deemed to be University).

#### **Authorship**

Co-authorship is permitted for up to two authors.

#### **Originality**

All submissions must be the original work of the author(s), unpublished, and not under consideration for publication elsewhere.

#### **Blind Review Policy**

To ensure a fair and unbiased review process, both the abstract and the full manuscript must not contain the name(s) or any identifying details of the author(s). A separate cover page must be submitted, clearly mentioning the name(s) of the author(s), their year of study or faculty designation, and institutional affiliation.

#### **Submission Format**

The abstract must clearly outline the research question, methodology adopted, and the expected contribution to existing legal literature. It must be between 300 to 500 words and submitted in .doc or .docx format, titled as:

Name of Author(s) – ACLSC Full Paper Submission

All submissions must follow the Bluebook 21st Edition for citations.

### **SUBMISSION CATEGORIES**

We welcome original, unpublished manuscripts in the following categories:

- 1. Long Articles (3,000–5,000 words, excluding footnotes): In-depth research-based analysis offering comprehensive insight into a specific issue within the broader theme.
- 2. Short Articles/Essays (1,500–3,000 words, excluding footnotes): Concise yet insightful explorations of focused topics, offering innovative arguments or critiques.
- 3. Case Notes and Legislative Comments (1,200–2,500 words): Analytical pieces examining recent judicial decisions, draft or enacted legislation, and their broader legal and societal implications.





## **ILLUSTRATIVE SUB-THEMES**

- 1. Comparative Criminal Justice Systems Analyzing how different legal systems approach criminal law.
- 2. Cybercrime and Digital Evidence The impact of technology on crime and legal responses.
- 3. The Evolution of Criminal Liability Historical and contemporary perspectives on criminal responsibility.
- 4. Human Rights and Criminal Justice Balancing human rights protections within criminal proceedings.
- 5. Sentencing and Penal Reform Examination of current sentencing practices and potential reforms.
- 6. White-Collar Crime A deep dive into corporate, financial, and economic crimes.
- 7. Juvenile Justice The treatment and rehabilitation of young offenders in criminal law.
- 8. International Criminal Law Prosecuting crimes against humanity, war crimes, and genocide.
- 9. Mental Health and Criminal Responsibility Exploring insanity defenses and the role of mental health in criminal law.
- 10. Gender and Crime How criminal law intersects with issues of gender and gender-based violence.





- 11. Police Powers and Accountability Examining the scope and limits of police authority.
- 12. Organized Crime and Terrorism Legal approaches to combating organized criminal networks and terrorism.
- 13. Forensic Science and Criminal Investigations The role of forensic evidence in the criminal justice system.
- 14. Victimology and Criminal Law The rights and role of victims in criminal proceedings.
- 15. Drug Offenses and Policy Legal frameworks surrounding drug crimes and decriminalization debates.
- 16. Restorative Justice Alternative approaches to criminal punishment focused on rehabilitation and reconciliation.
- 17. The Death Penalty and Its Abolition Exploring the legal, ethical, and societal debates on capital punishment.
- 18. Criminal Law and Emerging Technologies The impact of AI, blockchain, and other technologies on criminal behavior and law enforcement.
- 19. The Role of Public Opinion in Criminal Law How societal attitudes shape criminal justice policies and law reforms.
- 20. Environmental Crime Addressing legal responses to offenses against the environment and wildlife.
